

Regular Meeting Minutes Robla School District Governing Board May 10, 2018 at 5:30 P.M.

Call to Order

With a quorum present, Trustee Boyd called the meeting to order at 5:30 p.m. Present: Dennis Boyd (Presiding), Craig DeLuz, Kim Howard and Nuvia Cardona. Absent: Ken Barnes. Also present: Superintendent Ruben Reyes.

Closed Session

Having received no requests for public comment, the Board met in closed session to discuss the following: Public Employment: Instructional Assistant; Public Employee Discipline/Dismissal/Release; and Conference with Labor Negotiators – Agency Designated Representative: R. Reyes, Employee Organizations: RTA, CSEA.

Open Session

The Board came out of Closed Session at 6:36 p.m. RJ Smith led all present in the Pledge of Allegiance. Mr. Boyd announced that no action was taken in closed session. President Boyd acknowledged that any written communications to the Board had been distributed. There was no public comment.

Robla Education Foundation

John Reven said that he is still planning for Fireworks staffing.

Robla Park Community Association No representative was present.

Employee Associations

No representatives from RTA or CSEA were present.

Superintendent's Report

Superintendent Reyes announced that this is Staff Appreciation Week and handed each board member a picnic basket, our annual employee appreciation gift. He shared that CAASPP testing is occurring in the district this month and thanked IT staff and Mrs. Hunt that testing is running smoothly. He announced that SECC filmed in the district today and will create a 30-second ad that will run at Regal Cinemas in June. He participated at the California Ed Partners Fellowship and was the Keynote Speaker last week at the United Way donor/volunteer organization breakfast. He concluded by announcing that there is no facilities update but they have been working on the transition plan of 200 students from Taylor Street School to Main Avenue School due to construction at Taylor Street School.

Board Member Reports Trustees Howard, Cardona and DeLuz had nothing to report. Trustee Boyd reported that he enjoyed attending the DA Luncheon last Friday.

Discussion: Safety Resolution

President Boyd said he would like to table this discussion until the June 28 board meeting since Trustee Barnes is absent. Trustee DeLuz commented that he would feel more comfortable with the CSBA sample resolution largely because it focuses on the board's role as policy makers and educators and providing a safe, positive environment for our students.

Presentation: RJ Smith Eagle Scout Project Laura Lystrup introduced RJ Smith, Casa Robla Senior, Eagle Scout, Robla Preschool Alum and Robla Family Member. She shared a brief presentation of RJ's Eagle Scout Project which was the repair of the flag pole at Preschool.

Presentation: Maintenance and Operations Update Mike Henkel gave a breakdown of the Maintenance Department's organization and reviewed the department's accomplishments this school year. He listed projects planned for 2018-2019 as well as the bond projects.

Presentation: Federal Funding

Cindi Lyon, Director of State and Federal Programs, stated that Title I funding has been decreasing over time. She listed items funded from Title I such as Accelerated Reader, technology teachers, library materials and GLAD. She continued that Title II funding is also decreasing and listed items funded by these monies such as the Director of Curriculum. Finally, she shared that Title III funding is for English learners and immigrants and has decreased slightly. She listed items purchased with these funds such as bilingual materials for the DLI program and libraries, Homework Club, parent events and English Classes for Adults. Going forward, for federal accountability, we must submit a Federal LCAP addendum to the State LCAP which replaces the LEA plan. Unknowns are if there will be regulations, a yearly update or a Title III required report. There will be changes to the school dashboard that includes a progress indicator for English Learners.
