March 9, 2017 at 5:30 P.M.

Call to Order

With a quorum present, the meeting was called to order at 5:35 p.m. Present: Dennis Boyd (Presiding), Ken Barnes, Kim Howard, Nuvia Cardona and Craig DeLuz. Also present: Superintendent Ruben Reyes.

**Closed Session** 

Having received no requests for public comment, the Board met in closed session to discuss Public Employment – Title: Food Service Assistant and Gardener; Public Employee Performance Evaluation – Title: Superintendent; and Public Employee Discipline Dismissal/Release.

Open Session

The Board reconvened in Open Session at 6:36 p.m. President Boyd led the Pledge of Allegiance and announced that no action was taken in closed session. It was moved/seconded (DeLuz/Barnes) to adopt the agenda as published. Motion carried unanimously. (Ayes: Boyd, Barnes, Howard, Cardona, DeLuz)

President Boyd acknowledged that any written communications to the Board had been distributed. There was no public comment.

Christie Erhart, RTA President, reported that they met today for bargaining. There was no CSEA report.

Principal's Report

Sarah Neuhaus, Glenwood School Principal, stated that all teachers are completing second trimester report cards. She also reported on school activities including the following: Main Ave: United Way volunteers painted the playground area and support the primary grades in reading; Robla: Spring Carnival is on March 31 from 5 to 7 PM; Bell Ave: three of their students will be honored at the Crocker Art Gallery on Sunday for exceptional art pieces that they submitted; Glenwood: Eric Pinkins of the NY Giants spoke with students at an assembly about reading and joined KPMG volunteers in delivering books to every student; Taylor Street: Dental Screenings for grades 1-6 on March 8; Preschool: West Coast Falconry visits - This is raptor rescue foundation that brings large birds native to California in to teach our children about our state's wildlife.

Superintendent's Report

Ruben Reyes reported on the following activities and/or initiatives: a successful FPM Review led by Cindi Lyon; the Black History Month Parent Empowerment Dinner on February 28 with over 200 in attendance, a Strings Concert and recognition of Essay Contest winners, the Taylor Street Facilities Community Forum on March 2 that provided details for completed and planned facilities work; the Dual Language Immersion Program that now has two kindergarten teachers – Alicia Manes and Gavin Rubio; the tragic death of a Robla School parent and the assistance provided by our Psychological First Aid Team. He displayed the latest enrollment numbers.

Presentation: LCAP Update

Superintendent Reyes presented an LCAP update to the board. He sum narized engagement activities, displayed the State Priorities, our LCAP goals, reviewed 2016-17 actions and services, and explained the 5x5 student achievement. CBO Mike Henkel provided a look at 2017-2018 budget and discussed revenues in detail and the financial impact of PERS and STRS rate increases.

CBC Mike Henkel presented highlights of the second interim report. He discussed attendance trends, multi-year projection highlights, summarized fund balances and gave a preview of what is ahead.
