

Regular Meeting Minutes Robla School District Governing Board May 11, 2017 at 5:30 P.M.

Main Avenue School, 1400 Main Avenue, Sacramento, California

Call to Order

With a quorum present, the meeting was called to order at 5:30 p.m. Present: Dennis Boyd (Presiding), Ken Barnes (arrived at 6:57 p.m.), Nuvia Cardona and Craig DeLuz. Absent: Kim Howard. Also present: Superintendent Ruben Reyes.
