

Regular Meeting Minutes Robla School District Governing Board February 16, 2017 at 5:30 P.M.

Call to Order

With a quorum present, the meeting was called to order at 5:31 p.m. Present: Dennis Boyd (Presiding), Ken Barnes, Kim Howard, Nuvia Cardona and Craig DeLuz. Also present: Superintendent Ruben Reyes.

Closed Session

Having received no requests for public comment, the Board met in closed session to discuss Public Employment: Director of Curriculum and Assessment and Conference with Labor Negotiators – Ruben Reyes, RTA.

Open Session

The Board reconvened in Open Session at 6:43 p.m. President Boyd led the Pledge of Allegiance and announced that no action was taken in closed session. It was moved/seconded (DeLuz/Barnes) to adopt the agenda as published. Motion carried unanimously. (Ayes: Boyd, Barnes, Howard, Cardona, DeLuz)

Communications: Written and Oral

President Boyd acknowledged that any written communications to the Board had been distributed. There was no public comment.

Principal's Report

Leo Alvarez reported on various school activities, such as the following: <u>Taylor Street</u>: On February 22, the Sacramento Blues Society will perform at two student assemblies; <u>Main Avenue</u>: Teachers are preparing for the CAASPP testing and United Way will complete painting project on February 23; <u>Bell Avenue</u>: The PLST teachers and the Bell Avenue teachers have been collaborating to use the SOAR strategy "I Am Monologues;" <u>Robla</u>: On March 4, they are having Saturday Academy for High Achievers; <u>Glenwood</u>: On February 10, the African Drumming and Dance Troupe visited for a student assembly.

Superintendent's Report

Ruben Reyes reported on the following: Student Achievement Work Study Session on January 31 where primary and secondary teachers identified themes in the data; A draft letter to families regarding school safety and immigrant status; A plan to reduce our Employee Accrued Vacation Balance Liability; He extended an invitation to visit the Demonstration Classroom at Bell Avenue, Room 5; Reminded all of the Parent Dinner and Strings Concert on February 28; He announced that the newest Resilience session began on February 14, which is exciting because maintenance/custodial workers, food service workers and bus drivers have attended. He shared latest enrollment numbers.

<u>DeLuz</u>: He is in the midst of assembling schedule for visiting local politicians and encouraged trustees to register for CSBA's Legislative Action Day on March 23; he announced that Assembly bill 424 regarding possession of a firearm in a school zone to change the current law; he appreciated the positive support from Mayor Steinberg at the recent Sacramento County

School Board Association Dinner. <u>Cardona</u>: She apologized for not attending student achievement work study session due to her brother passing away that day in Panama. <u>Howard</u>: She is looking forward to Robla District growing and felt that the student achievement work study session very positive. <u>Barnes</u>: He registered to attend CSBA's Legislative Action Day on March 23. <u>Boyd</u>: He attended and thoroughly enjoyed his very first intramural soccer game today; he was impressed at the student achievement work study session with the intent and determination of staff to improve student achievement; He visited the 21st century classroom at Bell Avenue; He suggested the idea of a board retreat after March 23, from Friday night through Saturday all day.

Information: First reading of revised policies/regulations

Revised board policies and administrative regulations BP/AR 3553 – Free and Reduced Price Meals and BP 3555 – Nutrition Program Compliance were submitted for a first reading. No action was taken.

Presentation: Facilities Update Emilio Flores of CFW reported the following: Bell Avenue Demonstration Classroom: today was the final day of second vendor's furniture loan; he encouraged all to submit furniture feedback, which will be compiled and presented to the Board in April/May. Taylor Street Project: bids are due February 17 to modernize existing facilities and add a modular building; DSA expects to have plan review completed by March/April; CFW in discussions on how to proceed with construction with school in session. Bell Avenue School is next in Facilities Update cycle. CFW will return to the Board with a budget update to the Facilities Master Plan. He commended Adam VeVea for the new website design and is providing information to the District for the Community Forum at Taylor Street School on March 2.

Presentation: LCAP Update

Superintendent Reyes reviewed the timeline for the LCAP revision process. Mike Henkel, CBO, reviewed the budget impact to our LCAP for next school year according to current forecasts, stating that STRS and PERS increases will become the District's responsibility. Cindi Lyon, Director of State and Federal Programs, explained changes to the LCAP Update template then displayed the new rubric and a sample school district dashboard for suspension rates. Superintendent Reyes shared page one of Winter LCAP Update that is being developed.

Presentation: Teacher Professional Growth Project Ruben Reyes reviewed the timeline of the project; he identified design team members; reviewed REEd partners and explained concepts under exploration.

Public Hearing: Collective Bargaining Agreement – RTA President Boyd opened a public hearing to consider comments from the public, staff and board on the Collective Bargaining Agreement Initial Proposal from RTA to the District. Hearing no comments, he closed the public hearing.
