

Regular Meeting Minutes Robla School District Governing Board January 12, 2017 at 5:30 P.M.

Boardroom, 5248 Rose Street, Sacramento, California

Call to Order

With a quorum present, the meeting was called to order at 5:31 p.m. Present: Dennis Boyd (Presiding), Ken Barnes, Kim Howard, Nuvia Cardona and Craig DeLuz. Also present: Superintendent Ruben Reyes.

Closed Session

Having received no requests for public comment, the Board met in closed session to discuss Public Employment: Food Service Assistant and Certificated Teacher and Public Employee Performance Evaluation: Certificated Teachers and Social Workers.

Open Session

The Board reconvened in Open Session at 6:41 p.m. President Boyd led the Pledge of Allegiance and announced that no action was taken in closed session. It was moved/seconded (DeLuz/Barnes) to adopt the agenda as published. Motion carried unanimously. (Ayes: Boyd, Barnes, Howard, Cardona, DeLuz)

Communications: Written and Oral

President Boyd acknowledged that any written communications to the Board had been distributed and opened the floor to public comment. Taylor Street parent, Veronica Ellis, shared that while she is thrilled with GATE program she is concerned about lack of lighting. She has raised this issue at the last two site council meetings, but it has yet to be corrected. Another Taylor Street parent, Ilisapeci Burewaga, said that at a board meeting last year, she expressed concerns about facilities but nothing has been done. Issues she spoke about include unsanitary conditions in bathrooms and classrooms and lack of adequate lighting. Other areas needing attention are an upgrade to the intermediate playground, leaking portables, and regular changing of air filters.

Robla Education Foundation

John Reven reported that the foundation granted a request to Taylor Street 6th graders for Sly Park trip, distributed \$500 to librarian at each school, and helped fund a Robla 4th grade history class' overnight camping field trip to Sutter's Fort. He is working on confirming dates for the golf tournament.

Robla Park Community Assoc. No report.

Employee Associations

Christie Erhart, RTA President, reported that they presented questions to teachers regarding board member concerns about student test scores. This discussion guide for the PLCs was developed by her and the superintendent. There was no report from CSEA.

Principal's Report

Leo Alvarez reported on various school activities, such as the following: Main Avenue: students enjoyed having Farmer's Market, meeting Sarah Kesty for Author Day; Robla - Saturday, January 7th had Academy for High Achievers (AHA) where they work on STEAM activities; Glenwood: on January 17, they will have awards assemblies, Harvest of the Month Parent Nutrition Class and 3rd Grades trip to Crocker Museum; Bell Avenue: will have a garden work day with Young Leaders Society on Friday, February 3; and Taylor Street: parent fitness club is going strong, with parents either walking or doing indoor exercises every Thursday. All parents who participated took home a bag of healthy groceries.

Charter School Location Waiver Request President Boyd opened a public hearing to listen to comments from the public, staff and board on the charter school location waiver request for Paseo Grande Charter School. Hearing no comments he closed the public hearing. It was moved/seconded (Howard/Barnes) to adopt Resolution 778 approving charter school location waiver request to California Department of Education for Paseo Grande Charter School. Motion carried unanimously. (Ayes: Boyd, Barnes, Howard, Cardona, DeLuz)

It was moved/seconded (Howard/Cardona) to waive first reading and adopt following board policies and administrative regulations:

Requests for Future Agenda Items Trustee Howard requested a follow up report on addressing the Taylor Street parents' facilities concerns, suggested installing anonymous pantry boxes in the district and expressed her appreciation for the teacher meetings where they discussed student test results. Trustee Barnes asked the superintendent to investigate how the district can assess/improve communication with school sites councils. Trustee Boyd asked for a report on the Governor's Budget.
