

Regular Meeting Minutes
Robla School District Governing Board
November 8, 2018 at 5:30 P.M.

Call to Order

Mr. Dennis Boyd, President, called the meeting to order in open session at 5:30 p.m. Present: Dennis Boyd (Presiding), Craig DeLuz, Nuvia Cardona and Kim Howard. Absent: Ken Barnes. Also present: Superintendent Ruben Reyes.

Closed Session

Having received no requests for public comment, the Board met in closed session to discuss the following: Public Employee Performance Evaluation: Superintendent; Public Employment – Titles: Instructional Assistant, Bus Driver/Custodian; and Conference with Labor Negotiators - Agency Designated Representative: R. Reyes; Employee Organizations: RTA, CSEA.

Open Session

The Board returned from closed session at 6:37 p.m. Mr. Boyd led all in the Pledge of Allegiance and announced that no action was taken in closed session. It was moved/seconded (Howard/Cardona) to adopt the agenda as published. Motion carried. (Ayes: Boyd, DeLuz, Cardona, Howard; Absent: Barnes)

Communications

Mr. Boyd acknowledged that any written communications to the Board had been distributed. There was no public comment.

Reports

Nichol Sullivan, Chief of Personnel, stated that we are celebrating transitional kindergarten and kindergarten teachers, preschool teachers and secretaries this month. She read a few accolades received about each group then distributed certificates of appreciation to those being recognized.

There was no report from Robla Education Foundation, Robla Park Community Association or RTA. Lydia Hagar, President of CSEA Chapter 285, thanked the district for agreeing to send classified staff to a recent M&O conference.

Superintendent Reyes played a video from a program on KCRA called Common Ground that highlighted the district's partnership with United Way. He introduced Emilio Flores of CFW who reported that Measure H is currently at 65.01% passage rate with up to 100,000 ballots yet to be counted. The next official update will occur tomorrow at 4:00 PM. Mr. Reyes concluded by asking board members their date preference for a holiday dinner while at the CSBA conference.

Mrs. Howard, Mrs. Cardona and Mr. DeLuz had nothing to report. Mr. Boyd reported that participated in the Preschool, Bell Avenue and Robla Halloween parades. He helped distribute pomegranates at California Thursday at Glenwood School, He attended the RPCA monthly meeting where he learned that Olympus Center is being sold. He ended his report by thanking all who participated in supporting Measure H.

Presentations

<u>Facilities</u>: Emilio Flores of CFW reported that they have completed the concrete footings at Taylor Street and the building should be erected in December. He stated that CFW plans to submit a matching funds grant request to the state to support our full-day kindergarten programs. The process is competitive and is based on hardship (more than 60% bonding capacity) and free and reduced lunch count (above 60%). Robla qualifies on both counts.

State Testing: Superintendent Reyes introduced Mrs. Gail Hunt, Director of Curriculum and Assessment. She reviewed performance levels, explained the

scale score, displayed a sample student score report and showed the CAASPP State Results web page. She shared several slides with graphs illustrating results in English Language Arts (ELA) and Math by district, by school, by cohort, by school and grade level and by student group. She concluded by comparing district results with state and county results. Mrs. Lyon briefly discussed ELPAC results. Mr. Reyes shared the district's comprehensive approach to assessment, highlighted pockets of excellence and listed goals for academic improvement or how Robla is becoming more coherent.
