

Regular Meeting Minutes Robla School District Governing Board February 8, 2018 at 5:30 P.M.

Call to Order

With a quorum present, the meeting was called to order at 5:32 p.m. Present: Dennis Boyd (Presiding), Ken Barnes, Craig DeLuz and Nuvia Cardona. Absent: Kim Howard. Also present: Superintendent Ruben Reyes.

Closed Session

Principal's Report

Mr. Penman, Principal of Robla School, reported on various school activities including the following items: Robla - Feb. 7 Mutual Assistance Kickoff; Bell Avenue - 4-6th grade students enjoyed a visit from the B Street Theater on January 17; Preschool – Students love Pennies for Patients, a fundraiser for children who have lymphoma; Taylor Street - United Way volunteers recently painted the basketball poles & US Map in the quad area; Main Avenue - PTC is selling "Won't You Be My Valenslime," making slime to sell to students for Valentine's Day; Glenwood - Teachers attended the Dual Language Immersion Conference to gain valuable information.

Superintendent's Report

Superintendent Reyes reported on progress in implementing Hazel Health in our schools; he invited board members to the Parent Empowerment Dinner on February 28 where we will announce the winners to the student essay and poetry contest; discussed recruitment efforts for our Dual Language Immersion Program; finally, he announced that students from Mr. Crongeyer's Class wrote history plays that will be performed by the B Street Theater at all of our schools.

Board Member Reports Trustees Cardona, DeLuz and Barnes had nothing to report. Trustee Boyd attended Movie Night at Taylor Street and enjoyed seeing families there. He was interviewed by two 6th grade students regarding the history of Robla School.

Presentation: Facilities Update There was no Facilities Update presentation.

Presentation: Bell Avenue School Level Plan Principal Lisa Hall discussed her 2016-2017 ELA Data, ELD Data and shared analysis of ELA/ELD data. She reviewed ELA/ELA Planning Monitoring and Evaluating data. She defined GLAD as Guided Language Acquisition Design. She played a video showing the use of GLAD strategies in a kindergarten, 1st grade and 6th grade classrooms.

Presentation: Main Avenue School Level Plan Principal Sarah Neuhaus reviewed testing results and growth targets in ELA and Math. She showed a snapshot data of a fifth grader and a matrix that showed how teachers can identify which questions students are struggling with. One of their goals is proficiency in English so she discussed monitoring and evaluation for growth. Another goal is parent support so stated that they are holding "Parents are Students Too" classes to help support academics at home. Their final goal is School Climate so she explained initiatives they have implemented and how they monitor and evaluate progress.

Presentation: LCAP Update

Superintendent Reyes shared a presentation that discussed the plan development, the 2017-2018 plan in action, state priority areas, Robla LCAP goals and reviewed 2017-2018 actions and services. He showed the Robla District results on the State's 5x5 grid. Next, Mike Henkel, CBO, gave the board a look at the 2018-2019 budget. Superintendent Reyes shared that the district is in refinements/enhancements/expansion mode.
