



Regular Meeting Minutes
Robla School District Governing Board
April 12, 2018 at 5:30 P.M.

- Call to Order With a quorum present, Trustee Boyd called the meeting to order at 5:30 p.m. Present: Dennis Boyd (Presiding), Craig DeLuz, Nuvia Cardona and Kim Howard. Absent: Craig DeLuz. Also present: Superintendent Ruben Reyes.
- Closed Session Having received no requests for public comment, the Board met in closed session to discuss the following: Public Employee Performance Evaluation: Superintendent and Public Employment: Teacher, Instructional Assistant and Intervention Assistant.
- Open Session The Board reconvened in Open Session at 6:40 p.m. Trustee Boyd led the Pledge of Allegiance and announced that no action was taken in closed session. It was moved/seconded (DeLuz/Cardona) to adopt the agenda with the removal of Quarterly Marketing Progress Report presentation. Motion carried. (Ayes: Boyd, DeLuz, Howard, Cardona; Absent: Barnes)
- Communications: Written and Oral President Boyd acknowledged that any written communications to the Board had been distributed. There was no public comment.
- Robla Education Foundation Mr. John Reven said he is gearing up for the fireworks booth at Bings Market. Sue Sweet is going to be the stand manager this year.
- Robla Park Community Association No representative was present.

- Principal's Report No principal's report.
- Superintendent's Report Superintendent Reyes updated the board on Hazel Health, stating that 81% of consent forms were returned at Robla and at least 50% returned at all other schools. He informed them that KCRA visited the district today for a piece "Common Ground" and interviewed several staff members and filmed various events going on in the district. He advised the board that changes are coming in our district with our special education services and SELPA. He announced that administrators spent Monday interviewing candidates and observing demo lessons and they have offered three contracts, all of which were accepted. He shared that he will speak at SCOE's next Curriculum Breakfast on our parent engagement work. Finally, over break, he attended a meeting of the Latino Jewish Forum where he listed to a presentation by the Mexican consulate.
- Board Member Reports Trustees Howard and Cardona had nothing to report. Trustee DeLuz had apologize for his absence at the last meeting. Trustee Boyd expressed his appreciation for the student art and video gala event.
- Presentation: Facilities Update Emilio Flores, CFW Executive V.P, reported that Main Avenue School project is nearing completion. They will submit plans for the Taylor Street School project to DSA on Monday and are developing a transition plan for temporary housing at Main Avenue School for Taylor Street School students and staff during construction at their site. They will also plan a grand opening of the new building at Main Avenue School in the fall.


