

Regular Meeting Minutes Robla School District Governing Board August 23, 2018 at 5:30 P.M. Boardroom, 5200 Marysville Blvd., Sacramento, California

Call to Order

With a quorum present, Trustee Boyd called the meeting to order at 5:30 p.m. Present: Dennis Boyd (Presiding), Ken Barnes, Craig DeLuz and Nuvia Cardona. Absent: Kim Howard. Also present: Superintendent Ruben Reyes.

Closed Session

Having received no requests for public comment, the Board met in closed session to discuss the following: Public Employment: Teacher, Bus Driver/Custodian, Gardener, Intervention Assistant and Staff Secretary.

Open Session

The Board came out of Closed Session at 6:32 p.m. President Boyd led all present in the Pledge of Allegiance. Mr. Boyd announced that no action was taken in closed session. Communications

President Boyd acknowledged that any written communications to the Board had been distributed. There was no public comment.

Reports

There was no report from Robla Education Foundation, Robla Park Community Association or the Employee Associations (CSEA and RTA).

Superintendent Reyes reported on the following: (1) First Day of School – he visited various site and all seemed calm and organized; Councilmember Warren visited our DLI program at Glenwood (2) Employee Appreciation Picnic – he felt the picnic was a success and hoped that all were able to enjoy a tour of the new building at Main Avenue School; (3) Ready for Robla – students received new backpacks full of supplies, new clothes and shoes, a haircut, and lunch; (4) Robla Teacher Professional Growth System – moving into its second pilot year and was the subject of a podcast on Field Trip, produced by Frontline Education; and (5) I Care Fair – a new event planned by United Way, with more details are forthcoming.

Trustee Cardona said she enjoyed the Employee Picnic. Trustee DeLuz had nothing to report. Trustee Barnes reported he enjoyed the welcome back picnic and reported that his daughter enjoys recess more at Main Avenue School. He felt that the transition went smoothly. Trustee Boyd thanked everyone for participating in Ready for Robla and the Employee Welcome Back Picnic.

Information

Revised board policy 5030 – Student Wellness was submitted for a first reading. No action was taken.

Presentation

<u>Facilities</u>: Emilio Flores of CFW reported that students are occupying the new building at Main Avenue School though there are a few bugs to work out. The district will be submitting to the state this week upwards of \$5.6 million reimbursement for previous construction costs, which will be made available for future facilities projects. He provided an overview of the Taylor Street School project and reviewed the Taylor Street project cost negotiation process including a breakdown of additional scope. He explained the variance in the total budget and summarized the recommendations and actions required. With board approval, CFW will schedule a project kick off meeting on September 4 with construction to begin shortly thereafter.
